General Information:

The mission of the CAP Cadet Competition is to showcase “the full range of challenges in cadet life experienced at the squadron level, and new areas of learning that are important to America.”

The 2020 Colorado Wing (COWG) Cadet Competition will be held on Saturday, 14 March, 2020 at Colorado Military Academy (360 Command View, Colorado Springs, CO 80915). Team check-in will run from 0800-0820. Events of the day will commence with a competitor briefing at 0830. The award ceremony will begin at 1500 and we expect to conclude NLT 1530.

NB: It is important that when you register a team, you list your cadet competitors in order of CAP Grade from highest ranking on the team to lowest ranking on the team. This is so that as we randomly select team members for events, teams will remain as balanced as possible in their representation at the event.

(Updates to current version **highlighted**)

1. Eligibility

- The program is open to all cadet and composite squadrons. There are no special age or cadet grade requirements.
- Participating cadets must have completed Achievement 1.
- Multi-Squadron Teams. - Teams may draw cadets from a maximum of two squadrons.

2. Team Composition

- Teams consist of six cadets, with one cadet designated cadet commander. The designated cadet commander will be listed as “Competitor 1” on the registration
- Teams will have one accompanying senior member present for the duration of the day who is responsible for the team’s safety and adherence to the guidelines of the day

3. Form Submission

All cadet ** participants will email the following completed forms to marybeth.slocumb@cowg.cap.gov NLT 72 hours prior to the start of the event:

**All participating Senior Members are required to have a *current* copy of their CAPF 160 / CAPF 161 on their person at the event.

4. Events

Prior To Arrival:

- NLT than 72 hours prior to the start of the event a CPFT must be submitted via email to marybeth.slocumb@cowg.cap.gov using the form on page 4 of this guide. The PT test must be verified by the unit CC *and* a second senior member.

Onsite:

Onsite events will take place in a round-robin format. To preserve the integrity of the events, all competitors and accompanying senior members must not communicate with other members present (competitors, other team members, *and/or* spectators) for the duration of the competition. Failure to comply *may* result in a sportsmanship modification.

- Indoor Posting of Colors – 4 cadet team - **determined by participating team**
- Outdoor Posting of Colors – 3 cadet team - **determined by participating team**
- **Element** Standard Drill – 4 cadet team - **selected randomly**
- Written Exam - **all cadets**
- Uniform Inspection - 4 cadet team - **selected randomly**
- **Uniform Preparation** - 2 cadet team - **selected randomly**
- **Team Leadership Challenge** - **all cadets**

5. Uniform

The UOD for the event will be the Class B USAF Style Blues Uniform IAW [CAPM 39-1](#)

*Short-stacking of ribbons is permitted

6. Sportsmanship Modification

CAP cadets are expected to conduct themselves in an age-appropriate, professional manner at all times. The sportsmanship grade is a mechanism used to commend teams that demonstrate an extraordinarily high standard of personal conduct, and (if necessary) to penalize teams whose unacceptably poor conduct brings discredit to themselves and CAP. Infractions of conduct will result in 1-10 points assessed, depending not on the severity of the infraction (Core Value violations: e.g. disrespectful behavior, cheating, failure to submit paperwork on time, communicating with others not on the competition team during the competition period). Admirable conduct will likewise be recognized. The sportsmanship modification will be rarely invoked, however, for purposes declaring here, in advance, that sportsmanship modifications are permissible at NCC.

7. Appeals / Challenges

Ideally, challenges should be resolved at the lowest possible level. If a possible problem can be rectified immediately on-scene, the team commander should approach the event Judge directly, and respectfully to request relief.

If the matter is not resolved to the team's satisfaction on-scene, the team commander (i.e. Cadet 1 on the registration form) may file a formal, written challenge with the event director within 20 minutes of the event's conclusion. A written challenge must be the original work of the team commander; escorts and spectators are prohibited from assisting.

The Event Director may declare a challenged matter moot if the decision would not alter the results of one of the top two competitors in a given event.

Teams are expected to show deference to the judges' decisions and challenge only those matters that are both meaningful and objectively contrary to the event rules and procedures.

A challenge is by definition an appeal procedure because it seeks relief from a judge's or staff member's action. Accordingly, the Event Director's ruling on all challenges is final.
